SECTION-II GENERAL TERMS AND CONDITIONS

1. Scope of Bid:

- 1.1. The scope of the Bid shall be the purchase of Obsolete Fixed Assets Items for the FY-2024 listed in the attached Annexure of the Bidding Document.
- 1.2. All the Bids are to be completed and submitted to the SELLER in accordance with the Instructions to Bidders. Bidders are not required to submit a copy of the bid.

2. Eligibility:

- 2.1. The invitation for Bids is open to all interested scrap dealers/parties/individuals.

3. Cost of Bidding:

- 3.1. The Bidder(s) shall bear all costs associated with the preparation and delivery of its Bids, and the SELLER shall in no case be responsible or liable for those costs.

4. Bidding Documents:

- 4.1. The bidding procedures and terms & conditions are prescribed in the bidding document.
- 4.2. The Bidder(s) are expected to examine the Bidding Document, including all Instructions, Forms, and Terms before the submission of the bid. Failure to furnish all information required by the Bidding Document or submission of a Bid not substantially responsive to the Bidding Document in every respect will result in the rejection of the Bid.

5. Payment Terms:

- 5.1. **Advance 10%** of the total quoted value shall be submitted along with the bidding document/quotation.
- 5.2. **Balance 90%** shall be made within one week from the date of receiving of confirmed Sales Order/Award Notification and before picking up the Obsolete Fixed assets.
- 5.3. Payment shall be made in the form of Cash or Demand Draft/Cash Warrant.
- 5.4. In the case of Demand Draft/Cash Warrant, it shall be addressed to Tashi InfoComm Limited, Thimphu.
- 5.5. TDS (Tax Deducted at Source) and FCT (Foreign Contacts Tax) shall be deducted as per the existing Rules and Regulations of the Department of the Revenue and Customs, Bhutan (wherever applicable).

6. Inspection & Pick Up of Obsolete Fixed Assets & Consumable Items

- 6.1. All the interested bidders are expected to inspect the Obsolete Fixed assets before the submission of Bid/Quotation. Any form of grievances/complaints after the submission of the bid shall not be accepted or entertained.
- 6.2. The interested bidders shall inspect the obsolete fixed assets as per the time and place mentioned below based on the physical location of the obsolete fixed assets & consumable items.
- 6.3. For verification, the interested parties may contact Mr. Sonam Wangchuk Tamang, Procurement Officer, TIPL Head Office at mobile number +975 77811551.
- 6.4. The obsolete fixed assets items should be picked within one week from the date of receiving of confirmed signed Sales Deed/Award Notification and after fulfilling the payment terms under clause 5.

7. Bid Prices/Quotation:

- 7.1. The currency of the bid shall be in NGULTRUM (NU).
- 7.2. The quotation prices for every line item and category shall remain fixed and valid. The SELLER shall not accept any variation. However, the SELLER may choose to negotiate with the parties at its discretion.

8. Award of Goods:

- 8.1. **Obsolete Fixed Assets:** The bidder(s) quoting the highest AMOUNT for each category shall be awarded the Award Notification **except for motorbikes the award shall be made to the highest AMOUNT against respective line items.**
- 8.2. If the winning bidder(s) fails to execute the Sales Deed/Award Notification or fails to pay the balance 90% payment within the given deadline, the SELLER shall forfeit the 10% advance deposited and award the goods to the second highest bidder(s).
- 8.3. The interested bidders shall quote directly for each category as per the price schedule except for motorbike quotes for respective line items.

9. Force Majeure:

- 9.1. Force majeure shall mean such unforeseeable occurrences beyond the control of the SELLER and Bidder(s) which occur after the date of issuance of Sales Deed/Award Notification and which are not reasonably foreseeable at the time of issuance of Sales Deed/Award Notification and which effects are not capable of being overcome without the unreasonable expense or loss of time to the SELLER and the Bidder concerned, provided that the aforementioned conditions are met but not limited to:

- i) Natural catastrophes, earthquakes
- ii) Strikes and blockages
- iii) War or war-like conditions, mobilizations, revolutions or riots, an act of Public enemy, sabotage, terrorism.
- iv) Restriction by or actions, omissions, or interventions from Public Authorities (including but not limited to changes in laws, regulations or import/export, security restrictions).
- v) The Party who wishes to plead Force Majeure shall inform the other party of the First party's perception of the effects of such force majeure on the fulfillment of issued Sales Deed/Award Notification. Should any event of force majeure cause an increase in the time required for the performance of any part of the Sales Deed/Award Notification, an equivalent adjustment shall be made in the time required for performance.

However, if the force majeure situation continues for more than seven days, the SELLER and bidder shall decide whether the Award Notification should be terminated.

10. Termination:

- 10.1. In the event of any failure by the Bidder to perform any of its obligations under the issued Sales Deed/Award Notification or upon unsatisfactory performance, the SELLER shall terminate the Sales Deed/Award Notification by giving a prior written notice of seven days without any obligation to the SELLER. The 10% advance deposited to the SELLER shall remain forfeited.

11. Indemnity:

- 11.1. The bidder(s) shall comply with all the laws in force in Bhutan and outside. The laws will include all national, provincial, municipal, or other laws that affect the performance of the issued Sales deed/Award Notification and bind upon the Bidder(s). The Bidder(s) shall indemnify and hold harmless the SELLER against any and all liabilities, damages, claims, fines, penalties, and expenses of whatever nature arising or resulting from the violation of such laws by the Bidder(s).

12. Dispute Settlement:

12.1 If any dispute should arise in connection to the issued Sales Deed/Award Notification, the parties shall resolve it through good faith negotiations, with escalation to the senior TIPL management committee as needed. If negotiations fail, the dispute will be referred to the court.


